### What You Missed at the September Meeting

Our President Sal welcomed everyone back, including a new member from Glen Oaks and past members from the Huntington Chapter.

The guest speaker, Ms Jeanne Fredrikson, explained about another option available when hearing aids are not enough to improve our hearing. Our very informed speaker has many years of working in the field of hearing loss, first as a teacher and now as a manager from the Med-EL Corporation. During her presentation she showed videos and had hand-outs, and asked members in our chapter to contribute thoughts & questions about their Cochlear implants.

She discussed that if you do not understand speech about 50% of the time, age is not a factor and you may be a candidate for an implantable cochlear device.

Many details of what to expect including about 2 hours of surgery with one day or night in a hospital and about 3 to 6 weeks to start to work programming and rehabilitation.

This was an enriching and well planned discussion about Cochlear implants, and all questions from the members were answered. We hope in the future to invite Ms Fredrikson back to further discuss mapping etc, as she was an excellent speaker.

## Ask the Audiologist

**Question:** I have new hearing aids and will be travelling. Can I wear them on the plane?

Answer: You can wear your hearing aids in the airport and on the plane. The devices will NOT set off metal detectors. If you are wearing them, they should never be removed to go through security. Hearing aids can easily get lost, mixed-up or left behind if thrown into a change bin or the side pocket of a bag. If you choose not to wear them through security at all, take them off beforehand and put them away safely.

The airplane noise will not damage your hearing - hearing aids have a maximum output level and will not amplify the plane noise to an unsafe level. When all electronic devices need to be powered off during take off and landing, your hearing aids are not included and will not interfere with radar signals. If you have a streaming device such as Phonak's iCom, Oticon's Streamer, a Widex Dex, etc. these SHOULD be powered off until notified by the flight crew that it's OK. While it is always nice to have the devices on, especially if you are flying with a companion, you are not required by any air safety regulations or the airlines to wear them and can choose to leave them out the entire flight.

## Filings Detail Apple's Plans To Improve Support For Hearing Impaired Users

With this fall's launch of iOS 6 set to add support for new "Made for iPhone" hearing aids, a pair of new patent applications offer a glimpse of how Apple could even further benefit users who are hearing impaired. The applications published this week by the U.S. Patent and Trademark Office and discovered by *AppleInsider* are entitled Social Network for Sharing a Hearing Aid Setting and Remotely Updating a Hearing Aid Profile. They both describe smart hearing aids that could wirelessly connect to devices to make life easier for users with hearing issues. The applications come as Apple is set to offer built-in support for new "Made for iPhone" hearing aids later this year with the launch of iOS 6. The new hardware accessories will offer compatibility with Apple's latest-generation model, the iPhone 4S.

But Apple's newly published patent applications go much farther than just a certified iPhone accessory. Specifically, the social network patent describes a system through which users who rely on hearing aids could communicate with one another and share information in the interest of improving the overall quality of life of the members. "With the advent of programmable hearing aids whose signal processing can be at least partially modified, what is desired is providing a hearing aid user the ability to modify the audio processing of the programmable hearing aid in the context for which the hearing aid will be used," the filing reads.

Apple's proposed networking system would rely on a user's portable device, like an iPhone, that is connected to their wireless hearing aid. The iPhone would then communicate with other users and share settings so that they might obtain an ideal hearing aid configuration for their current location or activity. Ideal hearing aid settings could also be stored and shared through other devices, like a computer or television set.

The second patent, related to remotely updating the settings on a hearing aid, describes how a system could save different configured profiles for specific circumstances. This would allow the user of a hearing aid "to modify the audio processing of the programmable hearing aid in real time in accordance with the context for which the hearing aid is or will be used."

These stored, quickly selectable profiles could be shared between iPhones in Apple's social networking concept, which could make life easier for users with hearing issues. Both the social networking application and the concept for remotely updating a hearing aid profile were were first filed with the USPTO in January of 2011. Both proposed inventions are credited to Edwin W. Foo and Gregory F. Hughes.

## **Queen Wears Hearing Protection During Jubilee Concert**

Setting an example to her UK subjects, and perhaps the world, Queen Elizabeth II has reportedly worn hearing protection during an all-star rock concert celebrating her 60-year Diamond Jubilee.

A photograph taken from a television and published in Britain's *Daily Mail* shows a yellow earplug nestled inside the royal ears as the Queen listened to songs from Sir Paul McCartney, Sir Elton John, and other notable musicians.

It appears that the Queen is knowledgeable enough about the risks of hearing loss due to excessive noise from rock concerts. Since hearing ability naturally decreases as humans age, even for royalty, perhaps she also wore the protection to preserve her remaining abilities.

According to a recently published House Research Institute (HRI) study, 72% of teenagers participating in the study experienced temporary reduced hearing ability following exposure to a pop rock performance by a popular female singer.

If earplugs are good enough for the Queen of England, maybe younger Baby Boomers, like Prince Charles, will follow her example.
