#### The New Police Siren You Can Actually Feel

"The Howler" uses a low frequency vibration that can be felt from up to 200 feet away.



A new kind of police siren that emits low-frequency vibrations, is making waves — quite literally — in the town of Bartow, Fla. Although pedestrians may find it unpleasant, officers think it's a safer and more effective means of announcing their presence. "I don't know if I could go back to a regular siren and feel safe with it," Bartow Officer Bryan Dorman told WTSP.

Co-developed by a former Florida highway patrol officer, the Howler works by sending out a low-frequency vibration people can feel from up to 200 feet away. With electronic distractions becoming an ever-present part of our lives, the addition of the vibration to the lights and audible siren could be an invaluable safety tool.

Hundreds of police departments around the country have started using the system, including the NYPD.

While officers think the Howler is an effective device, not everyone thinks it's such a good idea. Noise control groups have voiced their opposition, calling the siren "disorienting."

"[The] siren easily triggers an involuntary stress response commonly known as 'fight or flight.' This results in the secretion of adrenaline, with ensuing spikes in cardio-respiratory rates, muscle tension, and elevated blood pressure," claims NoiseOFF, a coalition aimed at reducing noise pollution. "Infrasound is low frequency sound energy that affects the nervous system and prolonged exposure can lead to progressive medical conditions."

Police officers and noise-control groups may not agree on the Howler's viability as a safety tool, they concur on one thing: You know when a police car is coming.

# Verizon Selects TeleCommunication Systems to Provide Text to 911 National Gateway Solution

New Service Will Enable Customers to Send 911 Short-Code Messages to Emergency Response Centers

BASKING RIDGE, N.J. May 3, 2012

Demonstrating its continued commitment to advancing public safety, Verizon Wireless is taking steps toward offering many of its customers a new way to communicate with 911 call centers run by public safety officials. The company announced today that it has selected TeleCommunication Systems Inc., of Annapolis, Md., to participate in an initiative that will enable customers to send 911 SMS (Short Message Service) texts to the call centers, which are known as public-service answering points, or PSAPs.

While consumers should always first try to contact a 911 center by making a voice call, this enhanced SMS service, when deployed, will offer an alternative for customers on the Verizon Wireless network who are deaf or hard of hearing and cannot make voice calls or who could be placed in additional danger by speaking.

#### Earphone Can Impair Your Hearing Ability, Says Audiologist

ABUJA -Music lovers, especially the youth in the habit of using the earphone and putting it at a high volume may suffer hearloss, an audiologist, Mrs. Adewumi Ojetoyinbo has warned.

Ojetoyinbo told newsmen in Abuja that people should endeavour to protect their ears against noise, to avoid hearing disorder. "People should avoid exposing their ears to noisier environment and listening to music at a high volume with earpiece. Using earpiece at a high volume can reduce the degree of hearing of people involved in such habit."

According to her, it is a common practice among the youth in Nigeria, as many of them expose their ears to dangers through the use of earphone. "Some of them will put earpiece into their ears and turn the volume high, to the extent that the person next to him will be hearing the music. Before they realise it, their level of hearing will be going down gradually until it reaches hear-loss."

Ojetoyinbo said that increasing the volume of television set or the radio at a high volume could also be responsible for hear-loss, adding that increasing the volume of phone high while answering calls should be discouraged.

The audiologist noted that use of sharp objects to clean the ear could cause infection that could result in total deafness, adding that too much cleaning of the ear could cause injury to the ear-drum. "Don't put any sharp or pointed object into the ears whenever they itch; if your ears are full of wax go to the hospital, they will remove it for you," she advised.

Ojetoyinbo listed the major causes of hearing loss to include drug abuse, working in noisy environment such as industries as well as treatment of typhoid by non-qualified medical personnel. She said that hearing loss could be temporary or permanent due to infection or unusual activities, but could be corrected. "Rush to the hospital immediately you take any drug that affects your hearing so that it can be treated on time."

She advised that babies should be screened at the point of birth in the hospital to help detect partial or congenital hearing loss.
