Updates From HLAA National

HLAA Supports HR 1653, the Medicare Hearing Aid Coverage Act of 2015

On March 27, Representative Debbie Dingell of Michigan introduced the Medicare Hearing Aid Coverage Act of 2015. Representative Dingell spoke of the need for change.

"I have learned in recent months how many seniors are burdened by this problem," said Dingell. "When I learned of this, the ENT doctor who brought it to my attention told me more than half the patients she saw who needed a hearing aid were unable to afford or obtain one. No one should feel isolated, confused or shut out from the world around them because they cannot afford the treatment they need. This bill is just one piece of the puzzle to bring our fragmented and unnavigable health care system into the 21st Century to better serve seniors and families."

Representative Dingell's bill would improve access to hearing aids and related examinations by removing part of the Social Security Act that prevents Medicare from covering hearing aids. The bill also directs the Government Accountability Office (GAO) to conduct a study on insurance programs that provide services to help with hearing loss.

HLAA is thrilled that Representative Dingell has introduced this bill. We will be working to ensure that all members of Congress understand the importance of hearing health care for seniors.

April Meeting Notes

Our April 15 HLAA North Shore Chapter meeting was a wellattended, informative meeting. The presenter, Dr. Jacqueline Spitzer, is the Director of Audiology at New York-Presbyterian Hospital, Columbia University Medical Center. She is also the Director of the Cochlear Implant Team at Columbia. Her extensive background encompasses over 30 years experience in the field of audiology and cochlear implants.

Dr. Spitzer shared her knowledge about cochlear implants and the new hybrid cochlear implant, recently approved for use in the USA by the FDA. The hybrid is a new option

for some hearing impaired people who previously did not qualify for traditional cochlear implants, including those people no longer benefiting from traditional hearing aids. Until now, hearing aids have been the only option for those with mild to moderately severe high frequency hearing loss. Those who received little or no benefit from traditional hearings aides were simply "out of luck!" With the new hybrid cochlear implant, there may be another option for some adults. Presently, Cochlear is the only company in the USA that is approved to manufacture hybrids but the other companies are in the process of developing similar products. This is an exciting new development that will open the door to better hearing for many more people.

Dr Spitzer presented information and answered all questions about traditional cochlear implants and the newly approved hybrid cochlear implant. She detailed the 2 products and discussed each device, clearly defining who would benefit from each product based on their particular type of hearing loss. She gave an in depth presentation of the two devices and which type of person with a specific kind of hearing loss would be successful with each device. She explained how the traditional cochlear uses digital input while the hybrid cochlear implant hearing device uses both digital and acoustical means in a combination. The hybrid is now covered by most insurance plans including Medicare and Medicaid.

She let us know that technology has advanced so quickly recently that it can now reach many more people who were not able to be helped in the past. Hearing impaired people who previously have been told they did not qualify for cochlear implants may now qualify as candidates for either a traditional cochlear implant or the new hybrid, under newly revised government new government guidelines, based on their hearing loss. According to Dr. Spitzer, these devices are now capable of helping so many more people than in the past. Previous, only people with 0-20 % correct understanding of speech, considered severe to profoundly impaired could be candidates. With new

products and guidelines it is now possible for people with some hearing to be eligible for the hybrid cochlear implant!

Dr Spitzer patiently answered many questions from audience members. She stated that there is now a great deal of information out there and those who interested in finding out more about either device should seek out more information. Those interested can call the Cochlear Implant Team at Columbia University or another site in our area. In our area we are lucky to live near several major hospitals in Manhattan and on Long Island now doing this work. The process for either device involves an in depth workup, including a CT scan, a detailed audiology workup and a physical as both procedures are surgery involving anesthesia. She invited audience members to contact her or another center if they were interested or had additional questions. This was one terrific meeting. We learned a great deal about some new options now available to help enhance our lives by improving our ability to hear. We send a big thank you to Dr. Spitzer for sharing her extensive knowledge with us at our April 2015 HLAA meeting.

Osteoporosis Tied to Hearing Loss


Although the reason for the connection isn't clear, osteoporosis and sudden, temporary hearing loss often occur together, a new study from Taiwan finds.

A team led by Dr. Kai-Jen Tien of the Chi Mei Medical Center in Tainan City looked at more than 10,000 Taiwan residents diagnosed with the bone disease osteoporosis between 1999 and 2008. The researchers then compared them with nearly 32,000 people without the condition.

By the end of 2011, people with osteoporosis had a 76 percent higher risk of developing sudden deafness — an unexplained, rapid loss of hearing that typically occurs in one ear.


This type of hearing loss can occur all at once or over several days and is often temporary. According to background information from the researchers, about half of people who experience sudden hearing loss will regain their hearing, and about 85 percent of people who are treated for the condition recover some hearing.

The study was published recently in the Journal of Clinical Endocrinology & Metabolism.
